## Hawai'i Medical Service Association (HMSA) Official Rules for the

**2022 ILWU Local 142 Challenge Blood Drive Sweepstakes** 

By submitting an entry, you agree that you understand and accept the terms and conditions of these Official Rules:

- 1. **General.** No purchase is necessary to win a prize. You must be an active, retired, staff, member, family member or acquaintance to a member of ILWU Local 142 Union ("Union") to participate in the Sweepstakes. Must be a legal Hawaii resident at the time of entry and the time of any prize award. You must be at least 18 years old to enter. You must provide your personal email upon entering. You may only be eligible to enter after you donate blood at the Hawaii Blood Bank. Hawaii State ILWU LOCAL 142 ("ILWU LOCAL 142") has partnered with Hawai'i Medical Service Association ("HMSA") to administer the 2022 ILWU Local 142 Challenge Blood Drive ("Sweepstakes").
- 2. **Eligibility.** Employees of HMSA are not eligible to enter or win. You must be an active or retired Union member, or staff member, or family member or an acquaintance to a Union member.
- 3. **Promotional period.** The promotion for the chance for one (1) of five (5) prizes set forth in section 6 below will begin on July 12, 2022, at 9:30 a.m., HST and end on July 12, 2022, at 4:30 p.m., HST ("Promotional Period").
  - **How to enter.** This Sweepstakes consists of five (5) winners to be selected no later than August 5, 2022. To enter, blood donor volunteers ("Donors") will need to sign-up with ILWU Local 142 prior to July 12, 2022. Donors will need to provide full name, personal email address, and a contact phone number to ILWU Local 142 upon volunteering. The blood donation event will be held on July 12, 2022, from 9:30 a.m., HST through 4:30 p.m., HST. An ILWU LOCAL 142 representative and HMSA coordinator will assist Donors with scheduling appointments to make their blood donation. All blood donations must be completed by July 12, 2022, at 4:30 pm (HST). Once the Donor has completed their blood donation, the Hawaii Blood Bank will verify each Donor's blood donation. Once blood donation is verified, Donor will qualify for one (1) eligible entry into the Sweepstakes. Each Donor is eligible to win a maximum of one prize. Alternate method of entry consists of sending your first and last name, date of birth (verify age), phone number, and full address and email address with subject line "2022 ILWU Local 142 Challenge Blood Drive" directly to <a href="https://www.ching@hmsa.com.\_Entrants">lynn\_ching@hmsa.com.\_Entrants</a> may also enter by mail: HMSA, Attn: Lynn Ching 818 Keeaumoku St. Honolulu, HI 96814. Alternate entries by email or mail must be submitted by 4:30 p.m., HST on July 12, 2022. All entries become the exclusive property of HMSA and will not be acknowledged or returned.
- 6. **Prizes and odds of winning.** Win one (1) of five (5) \$100 Visa Gift Cards. Giveaway will be a chance to win one (1) of five (5) \$100 Visa Gift Cards (5 winners total). The odds of winning will be determined by the number of eligible entries received. Each eligible entry has an equal chance at winning a prize. You may only win up to one prize during the Promotional Period.
- 7. **Selection of winners.** The winners will be determined by a random drawing by an ILWU LOCAL 142 representative from all eligible entries received by the end of the Promotional Period. The winners' names will be drawn for the prizes no later than August 5, 2022, at 4:59pm, HST. By accepting their prize, the winner agrees to these Official Rules, including the use of their name, voice, and/or likeness for the purpose of announcing the winner of the promotion without further compensation. If the winner does not agree to be bound by these Official Rules, their prize will be forfeited, and another winner will be chosen. If the selected winner decides to forfeit their prize, written notice should be provided to HMSA as soon possible, and if HMSA receives no response from the selected winner within five (5) business days from the date of winner selection, the prize will automatically be relinquished, and a new winner will be selected. All prizes are nontransferable, and no cash or other prize substitution will be permitted except at HMSA's sole discretion. Winner is solely responsible for reporting and payment of any taxes on a prize. Winner may be required to provide his/her valid Social Security number to HMSA for tax purposes and/or complete an IRS W-9 form in order to claim

- a prize. The winner will complete an IRS W-9 and will be sent a form 1099 from HMSA. All Winners are solely responsible for all federal, state and local taxes on prize value, as applicable.
- 8. **Notification of winners.** The winners of the prizes will be notified by an HMSA coordinator or an ILWU LOCAL 142 representative via email at the email address provided at entry. All decisions are final and binding. Winner must contact HMSA or ILWU LOCAL 142 within five (5) business days from the date the notification is sent or made to claim their prize. Failure to respond with acceptance of prize within that five (5) day period will result in immediate disqualification of the selected entrant and a new winner will be selected. No exceptions will be made to this rule. HMSA is not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify winners. - 9. **Limitation of Liability.** HMSA AND VISA SHALL HAVE NO LIABILITY FOR ANY PERSONAL INJURIES, DEATH, PROPERTY DAMAGE, OR OTHER DAMAGES OR EXPENSES RESULTING FROM OR ARISING OUT OF ANY TRAVEL RELATED TO AN AWARD OR ANY OTHER ASPECT OF AN AWARD RECIPIENT'S ACCEPTANCE OR USE OF AN AWARD.
- 10. **Other conditions.** HMSA and their respective agents and representatives, their affiliates, subsidiaries, advertising, promotion and fulfillment agencies, and legal advisors are not responsible for and will not be liable for: (I) late, lost, damaged, misdirected, incomplete, unintelligible, or non-received entries; (II) telephone, electronic, hardware or software program, network, Internet, or computer malfunctions, failures, or difficulties of any kind; (III) failed, incomplete, garbled, or delayed computer transmissions; (IV) any condition caused by events beyond the control of HMSA that may cause drawings to be disrupted or corrupted; (V) any injuries, losses, or damages of any kind arising in connection with or as a result of the drawings, or from participation in the drawings; or (VI) any printing or typographical error in any material associated with the drawings. HMSA reserves the right in its sole discretion, to modify or cancel the drawings in part or its entirety, to comply with any and all federal, state, and local laws, rules, and regulations, or in the event the drawing becomes corrupted by technical error or unauthorized human intervention. HMSA reserves the right to change contest rules without notification.
- 11. **Privacy.** We are required by law to maintain the privacy and security of your personally identifiable health information. HMSA will never disclose any of your personal information either publicly or to the employer, except as necessary to respond to a request from you for a reasonable accommodation needed to participate in the Sweepstakes, or as expressly permitted by law. Medical information that personally identifies you that is provided in connection with the Sweepstakes will not be provided to the Union or your employer. Notwithstanding the foregoing, by signing up for the blood donation for participation in the Sweepstakes, you are allowing HMSA to contact ILWU LOCAL 142 regarding your blood donation information and for verification of employment or affiliation with Union, and/or to confirm Union's Donor list information. None of the health information you provide may be used in making any employment-based decision. Your health information will not be sold, exchanged, transferred, or otherwise disclosed except to the extent permitted by law to carry out specific activities related to the Sweepstakes or other plan services, and you will not be asked or required to waive the confidentiality of your health information as a condition of participating in the Sweepstakes or receiving an incentive. Anyone who receives your information for the purposes of providing you services as part of the Sweepstakes will abide by the same confidentiality requirements. For instance, applicable employers will be notified of active employee winners for purpose of payroll tax deduction on the prize.
- 12. **Choice of law.** All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules or the rights and obligations of you and HMSA in connection with the Sweepstakes, will be governed by and construed in accordance with the substantive laws of the State of Hawaii.
